◆ Complete the enclosed declaration, witnessed by a Justice of the Peace

Further Information Which May Be Required

- ◆ Please Note: Section 48 of the *Charitable and Non-Profit Gaming Act 1999* states:
 - ◆ “The chief executive may investigate the applicant, or a management member of the applicant, to decide whether the applicant or management member is a suitable person to hold the licence.
 - ◆ The chief executive may investigate a business or executive associate of the applicant to decide whether the business or executive associate is a suitable person to be associated with the applicant’s proposed operations under the licence.”
- ◆ In conducting our investigations into the applications, criminal history checks may be conducted on applicants. Accordingly, members of the management committee may be required at the time of application or at some other time during the term of licence to complete an Authority for Release of Information.
