You are advised that this self-exclusion order has effect immediately and remains in force until ____ / ____ / ____ (5 years from date of order given) or until a revocation notice given by you to the gambling provider takes effect.

To revoke this self-exclusion order, you must submit a revocation notice to the gambling provider within 24 hours of receiving this order. ¹ The revocation notice takes effect when it is given to the gambling provider. ²

Otherwise, to revoke this self-exclusion order, you may only submit a revocation notice to the gambling provider after 1 year of receiving this order. ³ The revocation notice takes effect 28 days after the day it is given to the gambling provider. ⁴

- If you contravene this self-exclusion order by taking part in approved gambling at, or entering or remaining in, a gambling provider's approved place of operation, the subject of this order, you may incur a maximum penalty of \$3,000 (40 penalty units).⁵
- A gambling provider, employee or agent is permitted to use necessary and reasonable force to prevent you from contravening this order by taking part in approved gambling at, or entering or remaining in, a gambling provider's approved place of operation, the subject of this order.⁶
