Owner of Freehold

The owner is stated on the Certificate of Title, available in a search from the Department of Natural Resources and Water (www.nrw.qld.gov.au).

Lessee of premises

The lessee is a person/company who has a lease from a lessor over the premises.

Mortgagee/Secured Creditor

A bank, building society, financial institution or an individual providing finance under a legal contract of credit.

Sub-lessee

Where there is a second lease, the terms sub-lessor and sub-lessee are used.
